# Allianz Technology Trust PLC

**Objective**

Allianz Technology Trust PLC ('ATT') invests principally in the equity securities of quoted technology companies on a worldwide basis with the aim of achieving long-term capital growth in excess of the Dow Jones World Technology Index (sterling adjusted, total return) (the 'benchmark').

**Outcome of value assessment Overall offers good value**

We have found the product to be of good quality, performing in line with expectations and costs and charges are reasonable for the benefits we expect the product to deliver, therefore we expect it to provide fair value for a reasonably foreseeable period.

**Limitations of Product:** The share price of an investment trust is not directly linked to the value per share of the investment trust's assets (the NAV) but may trade below (at a discount) or above (at premium) to the NAV. The rating is based on the discount over Allianz Technology Trust's most recent financial year. This factor has an **amber rating** because of the level of discount of the share price to net asset value.

As the company’s policy is to invest principally in the equity securities of quoted technology companies on a worldwide basis, the Dow Jones World Technology Index has been chosen as the benchmark index against which performance is measured.

**NAV return vs benchmark**



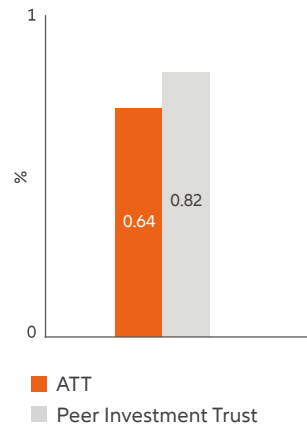
